



Announcement of the Teachers Council of Thailand

Re:

The List of Eligible Applicants, the Testing Dates, the Testing Venues, and the Testing Regulation Concerning the 11th Professional Knowledge Testing for Professional License of Foreign Teachers.

In pursuance to the Announcement of the Teachers Council of Thailand dated December 21st, 2012 regarding the 11th Professional Knowledge Testing for Foreign Teachers, the Council therefore announces the list of eligible applicants, the testing dates, the testing venues, and the testing regulation concerning the test for professional license of foreign teachers as following.

1. List of eligible applicants, testing dates and venues.

The list of eligible applicants, the testing dates and venues are as attached.

2. Testing regulation.

The test attendant shall observe the following rules.

- 1) The test attendants both male and female shall dress politely. Male attendants shall wear dress pant with a button-up/collared dress shirt. Jeans, cargo pants or shorts, and sandals are not allowed. Female attendants shall wear skirt with blouse. Jeans, sleeveless blouse, see-through dress, and sandals are not allowed.
- 2) The test attendant is required to present his/her valid passport together with the 11th testing Application Form ID to the test supervisor before entering into the testing room. Without such documents, the attendant shall be denied from the test participation.
- 3) In the case where the attendant changed his/her first and/or last name after the application date, the attendant is required to present the changed document to the test supervisor before entering into the testing room.
- 4) The test attendant is required to learn about his/her testing rooms, venues, and dates him/herself.
- 5) The test attendant should arrive to the testing room 30 minutes before the testing time. Except in an emergency case, the attendant shall not be allowed to attend the testing session 30 minutes after the session commenced. The attendant is therefore advised to study the route to the testing venue in advance.
- 6) The test attendant is required to attend the prescribed testing venue and room number. No attending permission shall be given to the attendant who goes to the wrong venue.
- 7) Only the 2B pencil, pen, and rubber are allowed to bring into the testing room.
- 8) Other writing materials and belongings such as purses, bags, and luggage are NOT allowed to bring into the testing room. No storage for the above items is provided. The test supervisor shall assume NO responsibility for the lost or stolen items.
- 9) Electronic or radio transmitter, mobile phone, and recorder are NOT allowed to bring into the testing room. Violation of this rule is subject to the test illegibility.
- 10) The test attendant shall observe the testing regulation and the testing supervisor instruction. Cheating in the test is a serious offense.

- 11) No noise is allowed in the testing room and area. During the test session, the attendant shall not leave the testing room without a permission of the test supervisor.
- 12) No smoking is allowed in the testing room.
- 13) No one shall leave the testing room before 45 minutes since the testing commenced.
- 14) The copying of test papers is not allowed. No test paper or answer sheet is allowed to take away from the testing room.
- 15) The test attendant is required to stop working on the test at the expiring time. No one shall leave the testing room before the permission to leave is given to by the test supervisor.
- 16) The test attendant who completed the test shall not make any noise annoying others who are in session.

The test attendant is required to observe strictly this regulation. Violation of any of these shall lead to the illegibility to the test. The answer sheet of the offender shall not be processed.

Important Note

1. The applicant who has applied and paid for the test but had no name appeared on the list shall make his/her claim in person for the test at the Professional Testing Unit, Secretariat Office of the Teachers Council of Thailand, Nakhonratchasima Rd, Dusit District, Bangkok 10300, **not later than April 11th, 2013**. Along with the claim, the applicant is required to present to the responsible officer the copy of the application form, the copy of the paid document, and the copy of the valid passport.

2. The test attendant is advised to study the test regulation thoroughly.

The applicant who presented the false information to the Council or has changed his/her personal information but neglected to notify the Council shall be disqualified from the test. He/she shall be guilty under Section 137 of the Criminal Code and shall not claim for any damage from the Council.
